Introduction

In 2019, Electricity Supply Board (ESB) issued green bonds aimed at financing projects that provide positive environmental impact, such as mitigating and reducing GHG emissions and generating renewable energy. In 2020, ESB engaged Sustainalytics to review the projects funded through the issued green bonds and provide an assessment as to whether the projects met the Use of Proceeds criteria and the Reporting commitments outlined in the ESB Green Bond Framework.

Evaluation Criteria

Sustainalytics evaluated the projects and assets funded in 2019/20 based on whether the projects:

1. Met the Use of Proceeds and Eligibility Criteria outlined in the ESB Green Bond Framework; and
2. Reported on at least one of the Key Performance Indicators (KPIs) for each Use of Proceeds criteria outlined in the ESB Green Bond Framework.

Table 1 lists the Use of Proceeds, Eligibility Criteria, and associated KPIs.

The work undertaken as part of this engagement included collection of documentation from ESB employees and review of documentation to confirm the conformance with the ESB Green Bond Framework.

Sustainalytics made all efforts to ensure the highest quality and rigor during its assessment process and enlisted its Sustainability Bonds Review Committee to provide oversight over the assessment of the review.

Conclusion

Based on the limited assurance procedures conducted,¹ nothing has come to Sustainalytics’ attention that causes us to believe that, in all material respects, the reviewed bond projects, funded through proceeds of ESB’s Green Bond, are not in conformance with the Use of Proceeds and Reporting Criteria outlined in the ESB Green Bond Framework. ESB has disclosed to Sustainalytics that the proceeds of the green bond were fully allocated as of 31 March 2020. The total amount allocated to projects is equal to EUR 498.5 mn. Please see Appendix 1 for a summary of allocation reporting by eligibility criteria.

¹ Sustainalytics limited assurance process includes reviewing the documentation relating to the details of the projects that have been funded, including description of projects, estimated and realized costs of projects, and project impact, which were provided by the Issuer. The Issuer is responsible for providing accurate information. Sustainalytics has not conducted on-site visits to projects.
